

# DIABETES AND WEIGHT-LOSS DRUG 'CHANGED MY LIFE,' SAYS SENATOR: 'I FEEL A DECADE YOUNGER'

U.S. senator said a GLP-1 drug changed his life — and now he's calling for widespread access to antiobesity medications.

In a New York Times op-ed on April 8, Sen. John Fetterman, D-Pa., wrote about his experience with Mounjaro (tirzepatide).

The injectable prescription medicine is primarily used to treat type 2 diabetes.

Fetterman was prescribed the medication in July 2024.

"As a stroke survivor, I was interested in studies showing [Mounjaro] could significantly reduce the risk of major cardiac events," the senator wrote. John Fetterman

"Even though I started taking it for my heart health, I've been struck by how much better it has made me feel across the board. It's made a significant impact on my overall health," he continued.

"Aches, pains and stiffness have vanished. Physically, I feel a decade younger,

as well as clearer-headed and more optimistic than I'd been in years. As far as side effects, I've also lost around 20 pounds."

Beyond lowering blood sugar, GLP-1 medications have also been linked to a range of other benefits, including improved heart health, neurological function and metabolic health, as Fox News Digital has reported.

Eli Lilly, maker of Mounjaro, also offers another version of the drug called Zepbound, which is the same medication approved for weight loss, chronic weight management and sleep apnea.

Other GLP-1 medications include Ozempic, Wegovy, Victoza, Saxenda, all made by Novo

Fetterman noted that GLP-1 drugs have been found to have beneficial effects on cholesterol, heart rate and heart inflammation.

"Some recent studies suggest they might even help curb alcohol addiction and support cognitive function, potentially slowing or preventing conditions like Parkinson's and Alzheimer's," he wrote in the Times op-ed.

In the op-ed, Fetterman called for expanded access to these medications, which can cost up to \$1,000 out of pocket if not covered by insurance.

"Currently, Medicare covers these drugs only under spe-

cific circumstances, such as for diabetes or heightened heart risk," he wrote. "And Medicaid coverage is even more limited."



Fetterman added that he was not compensated for sharing his experience.

"I'm just a guy who has benefited from these medications and wants to make sure that anyone else who could benefit from them can have access to them, too," he

# FBI Analyst Targeted in Kash Patel's Book Placed on Leave

The FBI has placed an analyst on leave whose name was ■ on a list of alleged "deep state" actors in a book written by FBI Director Kash Patel, two people familiar with the matter told NBC News.



This was first reported by the New York Times. It's unclear what reason the FBI gave for the move, and the agency declined to comment.

Brian Auten, a Russia expert, was the employee who was placed on leave. He was also among the FBI employees recommended for internal discipline by former FBI Director Christopher Wray over mistakes made in connection with the 2017 investigation into links between then-candidate Donald Trump and the Russian government.

A later review by the Justice Department inspector general found no evidence that any FBI employee acted out of political bias in the Russia investigation.

Patel included Auten on a list of roughly 60 alleged "deep state" actors in his 2023 book, "Government Gangsters." Patel denounced the FBI analyst by name, writing: "The fact that Auten was not fired from the FBI and prosecuted for his part in the Russia Gate conspiracy is a national embarrassment."

Patel also accused Auten of downplaying information found on the laptop of former President Joe Biden's son, Hunter Biden.

The FBI director has disputed that the list in his book is an enemies list.

Patel has his own links to the 2017 investigation into ties between President Donald Trump's 2016 presidential campaign and the Russian government.

At the start of Trump's first term, Patel worked for then-Rep. Devin Nunes, R-Calif., as a staffer on the GOP-led House Intelligence Committee.

In that role, Patel authored a memo accusing the FBI of making mistakes when it obtained a warrant to conduct sur-



LOS ANGELES — The biggest showstopper on the menu at Dodger Stadium this year may be a \$40 hot dog.



#### **February Housing Market Improves In Los Angeles Bucking State Trend** Statewide, Median Home **Price Dropped from January to February**

LOS ANGELES, CA — Home prices in the city of Los Angeles rose slightly in February compared to the previous month, and higher than housing prices one year ago, the California Association of Realtors announced Tuesday.

The \$824,000 median price of an existing single-family home last month reflected a 0.6% increase from January's \$820,000 sales price in the L.A. metro area. The February figure was a 4.4% increase from \$790,000 one year ago, according to the report.

In Los Angeles County, \$852,190 was required to purchase a single- family mortgage rates at the beginning of February, but the public's growing concern of a recession may also have played a role in the slowdown in housing demand in recent weeks, the report said.

The February statewide median price increased on a year-over-year basis for the 20th straight month, but the gain recorded was the smallest since July 2023, according to CAR.

On a month-to-month basis, the February median price dipped from the prior month, and the monthly drop was larger than the 10-year historical average dip of 0.7% recorded between the two months. The downward trend in the statewide

home last month, a 3.9% decrease from January. A year ago, \$817,100 was the cost of a single-family home, CAR said.

Home prices in Orange County also increased last month, from \$1.43 million in January to \$1.46 million in February. In February 2024, the same home cost \$1.35 million, according to the survey.

Riverside County saw a 0.3% increase to \$646,840 for a single-family home in February, from \$645,000 in January. The price one year ago was \$624,900, CAR

February's statewide median home price was \$829,060, down 1.2% from January but up 2.8% from \$806,480 in February 2024. Year-to-date statewide home sales edged up 2.6%, the survey

Also statewide, CAR noted, California's pending sales in February dipped from last year's level for the third consecutive month, but the drop was much smaller than the decline observed in January. The sales dip of homes in escrow could be due in part to a jump in median price will likely reverse in the coming months, however, as home prices typically begin rising in March and continue climbing until the end of the homebuying season in August, according to the report.

"California home sales rebounded strongly in February after a sluggish start to the year, supported by increased buyer activity and more available homes on the market," CAR President Heather Ozur said in a statement.

"Lower borrowing costs made homeownership more accessible to buyers who were previously sidelined by affordability challenges, while the rise in available inventory will help ease some of the competitive pressures that have defined the market in recent years and set a positive tone for the market for the rest of the year."

The median number of days it took to sell a California single-family home was 26 days in February, up from 22 days in February 2024.

#### If You Invested \$1 in Coca-Cola in 1925, Here's What It'd Be **Worth 100** Years Later

esides being one of the most iconic brands in **D** the world, Coca-Cola (KO) stock has boasted consistent returns for many decades.

The company went public in 1919 for \$40 a share. Suffice it to say that a lot has changed since

So if you had invested \$1 in Coca Cola (KO) a century ago, how much would you have had today? Coca-Cola in 1925

In 1925, shares of Coca-Cola sold for \$153.625, according to Coca-Cola's historical reporting. Even then, it paid a dividend of \$7 per share.

As of this writing, Coca-Cola trades at around \$70 per share. But the company's stock has split since 1925, and more than a few times.

#### **Stock Splits**

Coca-Cola has split its stock no fewer than 11 times since 1925. An analysis by Nasdaq found that a single share of Coca-Cola bought in 1925 would have multiplied into a massive 9,216 shares today.

At \$70 a share, 9,216 shares would be worth \$645,120 today.

If you had bought only \$1 worth of Coca Cola stock, that would be worth around \$4,200 today. Put another way, you'd own around 60 shares

Ultimately, an investment that started at \$1 and grew to \$4,200 over 100 years delivered an annualized return of around 8.7%.

#### **Dividends**

Coca-Cola enjoys status as a "Dividend King" a company that has consistently raised its dividend every year for at least 50 years. Not many companies can claim that title.

In Coca-Cola's case, it can boast 63 years of consecutive dividend increases. And it's been paying dividends since 1920. How many companies can

Unfortunately, there aren't accurate records of exactly how much those reinvested dividends would have added to your total return over the past 100 years. But if you owned 60 shares at \$70 per share, at its current dividend yield of about 2.91%, you'd be collecting over \$122 each year in dividends on your \$1 initial investment.

Bill Gates has revealed the amount of money his kids will inherit after his death.

While appearing on an episode of the Figuring Out with Raj Shamani podcast, the Microsoft cofounder, 69, explained that he will leave a very small percent of his fortune to his three children, but it will still amount to a huge financial sum.

"In my case, my kids got a great upbringing and education, but [they will get] less than 1 percent of the total wealth, because I decided it wouldn't be a favor to them," Bill — who shares daughters Jennifer, 28, and Phoebe, 22, plus son Rory, 25, with ex-wife Melinda French Gates — said.

Bill is currently worth \$102.2 billion, according to Forbes' 2025 World's Billionaire List, which means his kids' inheritance would equate to over \$1 billion each.


The father of three is the thirteenth richest person on the planet, behind Elon Musk, who leads the list, and others, including Mark Zuckerberg in the No. 2 spot and Jeff Bezos following in third.

According to Bill, he isn't interested in any of his kids following in the family business. "It's not a dynasty. I'm not asking them to run Microsoft," he explained on the podcast.

"I wanna give them a chance to have their own earnings and success, be significant and not overshadowed by the incredible luck and good fortune I had," continued the businessman.

When asked specifically if Jennifer, Rory or Phoebe had ever shared their disappointment that the majority of their father's massive fortune would not be theirs, Bill said, "You don't want your kids to ever be confused about your support for them and your love for them."

"So I do think, explaining early on your philosophy that you're gonna treat them all equally, and that you're gonna give them incredible opportunities, but that the highest calling for these resources is to go back to the





neediest through the foundation, [was important]."

Bill, who has long pledged to give the majority of his wealth to address social problems, told CNN in 2024 that he's currently giving away money at a rate of \$9 billion a year.

He also told the outlet that he believes he will meet his goal of no longer being one of the wealthiest men in the world in about 20 years.

"I have more than enough money for my own consumption," Bill said at the time. "I'm getting myself to go down the list, and I'll be proud when I fall off altogether."

Years earlier, the philanthropist said he planned to give "virtually all" of his wealth to The Gates Foundation, which he and his ex founded in 2000.

"I have an obligation to return my resources to society in ways that have the greatest impact for reducing suffering and improving lives," Bill wrote on X.

#### 3 Indigenous Wine Recommendations from Owamni by The Sioux Chef

The Minneapolis restaurant has made headlines for its decolonized food menu, but its drinks program also honors Indigenous ingredients and producers.

Founded in 2021 by Chef Sean Sherman in Minneapolis, Owamni by the Sioux Chef has become known for its decolonized food menu, which doesn't use any ingredients that were introduced by European settlers, such as dairy, wheat flour, and cane sugar. But what does a decolonized drinks program look like?

"Sean is Lakota Sioux and the original bar manager was Kareen Teague, who's an Anishinaabe or Ojibwe man, and those are the two prominent Indigenous groups from this region," says front-of-house manager Chrissy Sierra. "So [the drinks menu] was born of having the food represented by Lakota folks and the Anishinaabe folks represented in the beverage menu with names and ingredients."

For its non-alcoholic cocktail program, the restaurant sources ingredients that are indigenous to the region, like manoomin (wild rice) and sarsaparilla, and omits any that were introduced to the Americas by European settlers (with the exception of certain herbs like chamomile and lavender that are sustainably grown and "beneficial to our health and well-being," says Sierra). Since bartenders don't use any cane sugar or citrus in cocktails, sweetness may come in the form of agave or maple sugar. For acidity, they might use dried-up sumac berries as a souring agent or play around with the pectins of fresh berries to add texture to a cocktail. "It's been a fun challenge," says Sierra

On the other side of the menu, Owamni's wine list is entirely BIPOC-sourced, and includes producers from winemaking regions like Mexico's Bruma and South Africa's Kumusha Wines. The beverage program particularly focuses on maintaining a selection of bottles from Indigenous producers around the world. "I like having a wine list that makes people think twice," says Sierra.

Here are three brands from Indigenous producers Owamni recommends to seek out.

#### **Twisted Cedar**

This wine brand is fully owned by the Cedar Band of Paiute Indians, one of five bands of the Paiute tribe of Utah. With vineyards in Lodi, California, the winery is Lodicertified, meaning it maintains more than 150 sustainability practices. "They're a leading sustainability producer, and they've actually influenced other wineries in that region to become Lodi-certified," says Sierra.

"[These rules mean they're] not just organic, they're also treating workers a certain way, treating the land a certain way and not harmfully extracting grapes and resources from the lands," she says. "That's why I really appreciate Twisted Cedar's products. My favorite of theirs is probably the pinot grigio but

we also carry their petite syrah and we occasionally serve their moscato for special events."

Twisted Cedar also produces a chardonnay, cabernet sauvignon, zinfandel, and malbec.

#### te Pā Wines

Sierra says she likes to put an emphasis on Indigenous wines that aren't only sourced from the Americas. "It's a testament to me that Indigenous people are all over the world," she says. Founded by Haysley MacDonald, a New Zealander who traces his Māori ancestry back to early settlers who landed on the country's Wairau Bar 800 years ago, te Pā Wines produces wines in New Zealand's famed Marlborough region.

MacDonald and his family began converting their existing dairy and crop farm into vine-yards in 2003, and officially launched the brand in 2011 with vineyards in the Wairau Bar and Awatere Valley. Sierra particularly enjoys pairing the label's wines with the seafood-forward dishes that executive chef and Pacific Northwest native Lee Garman created for the summer menu. "I thought it was really romantic to have both sides of the Pacific Ocean represented in the restaurant as well," she says.

In addition to the pinot noir and sauvignon blanc that Owamni carries, te Pā produces chardonnay, pinot gris, and pinot noir rosé bottlings, among others. MacDonald also sells wines from the te Pā Reserve, Pā Road, Koha, and Montford Estate labels.

#### **Camins 2 Dreams**

This minimal-intervention, LGBTQ-owned label was founded in 2017 by wives Mireiba Taribó and Tara Gomez with grapes grown from vineyards in Sta. Rita Hills, an appellation in California's Santa Barbara County known for its relatively cool climate. It is bottled by their own Kalawashaq' Wine Cellars. A descendant of the Chumash tribe with a degree in enology, Gomez previously produced wines under the Kitá label for the Santa Ynez Band of Chumash Indians, making it the first brand owned by a Native American tribe, before parting ways in 2022.

Owamni has carried Camins 2 Dream's grüner veltliner, which has aromas of pear, green apple, and white flowers. Camins 2 Dreams mainly focuses on cool climate grüner veltliner and syrah, and also produces an albariño and gamay, among other bottlings.

# Self-Driving Cars in 2025: Where We Are Right Now According to Ride Al

Key considerations for autonomous vehicle development in 2025.

The inaugural Ride AI conference has just concluded in Hollywood, California. This meeting of minds included innovators and influencers on topics related to self-driving cars, entailing hardware, artificial intelligence, and human experience, all in the context of the global future of mobility. At Ride AI, luminaries from across the autonomous driving space met to discuss current focuses and future opportunities for getting people around without people being in control.

Many companies are focused on creating equivalents to or improvements on consumer-ready systems like Tesla's Full Self-Driving or General Motors' Super Cruise. But a recurring notion through the day was that expanding autonomous capabilities of privately owned vehicles is only one small part of the overall pursuit.

The Toyota Research Institute (TRI) thinks autonomous driving development shouldn't just be for its own sake—there needs to be purpose. TRI's representatives see relatively near-term technologies as less of a replacement and more of an assistant or teacher for human drivers. Using the self-drifting Supra we previously rode in as an example, TRI hypothesized how such capabilities could teach a driver how to better control their car and intervene in scenarios like a hazard-induced skid that pushes the limits of a driver's skill. TRI encouraged others in the space to not be constrained by narratives of what autonomy is or isn't.

In that sense, work continues to create foundations on which autonomous applications can be built. Nuro is one example. Its early focus was on creating driverless delivery vehicles only intended to carry cargo, not human passengers. However, as Nuro developed, it realized it was matching or outpacing major mainstream automakers. Now it aims to license its autonomous vehicle tech stack to other producers, be they producers of passenger vehicles, roadgoing delivery drones, or something else.

Likewise, Wayve is taking a hardware-agnostic approach, developing an AI-based driving brain that can apply to vehicles of different types and with different sensing systems. Wayve wants to meet its clients' needs by developing an adaptable logic for autonomy from Level 2 up to Level 4. It can function with sensing done by a relatively simple camera-only system or one combining cameras, radar, and lidar. Wayve can train its driving AI in accordance with its clients' hardware parameters and user experience preferences.

User experience is vital for any brand looking to leverage autonomy; using self-driving technology must assuage fears and provide tangible benefits for users whether they are individuals or institutions. User experience is a key consideration at Waymo as it earns and retains new riders. That shows up in small ways, like allowing a rider to choose the onboard music, or correctly rendering details in surrounding traffic, or using interior sensors to alert a rider if they leave something behind.

But driving performance is paramount to Waymo's user experience considerations, and that remains a challenge. Waymo's goal is to deliver consistently safe, predictable, uneventful rides, but how a Waymo car knows to do that in somewhere like San Francisco is vastly different than doing so in Los Angeles, and those locations are subject to the same California traffic regulations. Factors like terrain, driving pace, and road conditions are quite different between those cities, and a Waymo vehicle must know how to navigate each with equal skill. As Waymo seeks to expand into global markets like Tokyo, it needs to learn entirely different driving styles in remarkably different places yet deliver that same user experience.

How autonomous vehicles might learn better driving behaviors is another complex part of the equation. Although sensor-strewn autonomous vehicles collect vast real-world road data every day, that's insufficient to generate logic for all the potential scenarios a self-driving system may encounter. Leaders from Mobileye and Bot Auto stressed the importance of AI simulations—specifically, accuracy of those simulations—to continually, iteratively generate training knowledge for autonomous driving systems. Rather than use distance driven in simulations as a metric, measuring accuracy of simulations is at least as important. That accuracy can be based on typical road data, as well as by re-creating accidents and hazards. But no matter how precise AI simulations might become, realworld data must remain part of the pursuit so that hardware problems or road scenarios outside of AI's grasp can be part of the considerations.

The United States regulatory environment poses its own impediments to autonomous vehicle deployments. Fragmented and remote oversight by different local and federal agencies leads to a confusing, inefficient path to getting technology on the road. China could serve as a model for structuring a regulatory framework for autonomous vehicles. That country's government is relatively receptive to self-driving cars, establishing clear regulations and procedures that creators can reference to self-certify their developments. With these rules laid out clearly and transparently, technologists and consumers alike have less ambiguity about an autonomous vehicle's qualifications or capabilities. As such, robotaxi services in China such as Baidu's Apollo Go or Pony. Ai find increasing popularity and integration on urban roads.

Big ideas and insights were in no short supply at the Ride AI conference. Yet this diversity of thought also indicated a need for closer alignment between all related parties. With this, technology developers, automakers, and government regulators can reduce inefficiencies and increase understanding for what it takes to succeed in tomorrow's autonomous vehicle industry. The first Ride AI provided an environment for these synergies to take hold—so discussions at future editions of the conference can more quickly accelerate autonomous mobility.

In 2008, the company cashed in when they sold to Belgium beer powerhouse InBev for a whopping \$52 billion. Many people don't realize that Budweiser has an American history now, but not an American future. Luckily, the owners may have changed, but the taste has stayed the same.

sweet too, with best friends Ben Cohen and Jerry Greenfield opening their own parlor in 1978.

In 2000, Ben & Jerry's announced it had been bought by London-based conglomerate Unilever. The deal was struck for \$326 million, with Unilever being the highest bidder out of three different companies looking to make the takeover. The purchase helped to boost Unilever's portfolio.

# FAMOUS MURDERS THAT REMAIN UNSOLVED

espite what television would have you believe, not every murder is solved in under an hour. No matter how much effort police put into the cases at the time and amateur sleuths do afterward, some murders will never be solved.

That's not to say that all unsolved murders are created equal. For some, almost everything about the case is unknown: the culprit, the victim's identity, the method, the motive. On occasion, the best the police can tell the public is that someone was definitely killed, but anything after that is nebulous. With other cases, everyone knows who did it, but they managed to get acquitted or gave the police an alibi. In still others, the only reason that witnesses aren't pointing fingers at the culprit is that these fingers will be immediately cut off — along with their heads.

However, for what little good it did for the victims, sometimes being unable to solve a murder drives those left behind to improve the world so that no one else has to suffer the same fate.

Alexander Litvinenko: radioactive tea



Alexander Litvinenko was a former lieutenant colonel in the Russian FSB before receiving political asylum in Great Britain after being charged with abuse of office. He was bold about making enemies of powerful people, such as telling Indymedia London that Vladimir Putin is "the originator of the acts of terrorism in London" and that the Russian special services engage in terrorism worldwide. When accusations against the Russian government come out of one's mouth, one must be careful what goes into it.

No amount of polonium is safe to have in one's body, but the dose Litvinenko received was unambiguous. He lived for three weeks after the poisoning. Whoever did this not only wanted to silence him but demonstrate what could happen to their enemies.

Dmitry Kovtun, an ex-KGB agent, told the BBC's Russian service that the accusation of his involvement was "completely absurd," though he was with Andrei Lugovoi, the chief suspect. The two met Litvinenko at the Millennium Hotel on November 1, 2006, when it is suspected that they spiked his tea with polonium, according to The Telegraph. After the murder, Lugovoi became a celebrity in Russia and was elected the MP of the Liberal Democratic Party.

Given the reach of the likeliest sources of his murderers, it is no surprise that the case has yet to be solved. Those who might have information are less likely to want to go public with it for fear that they could meet a similar fate.



### THE #1 FOOD YOU **SHOULD LIMIT TO REDUCE YOUR RISK OF HIGH BLOOD** PRESSURE, ACCORD-**ING TO DIETITIANS**

ore than half of American adults have high blood pressure (aka hypertension), a silent condition that raises the risk of heart attack and stroke. Yet, as prevalent as high blood pressure is, there are steps you can take to prevent it. One of the most powerful is diet. While there are lots of foods to protect against high blood pressure, there are others that can cause it. And research has found that one of the biggest offenders is processed deli meat. It's so potentially troublesome that one study found that consuming as little as 17 grams of processed meat per day (slightly more than a half-ounce) may increase a person's odds of hypertension.

If you're eating a deli sandwich while you're reading this, don't panic. One meal won't cause hypertension. But there are important reasons to limit this blood pressure-raising food. Read on to learn why deli meat spells bad news for blood pressure, plus dietitian-approved alternatives to keep your numbers in check.

#### HOW PROCESSED DELI MEAT MAY INCREASE THE RISK OF HIGH BLOOD PRESSURE

#### It's High in Sodium

Food manufacturers add sodium to deli meat to improve taste and help maintain texture and shelf life. "Deli meat is one of those foods where the sodium content can be surprisingly high," says Drew Hemler, M.Sc., RD, FAND, a registered dietitian and lecturer and advisor in multidisciplinary studies at Buffalo State University. "A standard 3-ounce portion—just a few slices—can deliver a serious sodium hit." Take deli ham, for instance. One 3-ounce serving packs roughly 750 milligrams of sodium. That's roughly two-thirds of the maximum 2,300 mg of sodium most of us should eat in an entire day (and half the 1,500-mg limit the American Heart Association recommends for people with high blood pressure).,

Why is sodium such a problem? "High sodium content may cause your body to retain water, increasing blood volume and putting extra pressure on your blood vessel walls, which directly impacts blood pressure," says registered dietitian Patricia Bannan, M.S., RDN, author of From Burnout to Balance. Considering the typical American consumes an average of 3,400 mg of sodium daily, every bite counts. Since even reduced-sodium deli meats can contain surprisingly high sodium, label reading is a must.

#### **It Contains Blood Pressure-Raising Preservatives**

Sodium isn't the only additive in processed deli meat that's bad for blood pressure. Many deli meats also contain added nitrates and nitrites. These ingredients are added during processing to improve color and flavor and protect against bacterial contamination.

It doesn't help that these substances are confusing! While nitrates and nitrites naturally found in fruits and vegetables have been found to be beneficial for blood pressure and heart health, nitrates that are added to processed foods, like deli meat, have the opposite effect. According to emerging research, added nitrites may raise blood pressure by narrowing the arteries. In addition, these compounds have also been linked to insulin resistance, coronary heart disease and cancer. So, it's a good idea to limit them as much as possible.

#### It Lacks Fiber

When you think of fiber, digestive health might be the **E** first thing to come to mind. However, fiber also plays an important role in heart health, including blood pressure. In fact, research published in the American Heart Association's journal Hypertension recommends dietary fiber as a treatment for blood pressure control. That's because fiber is believed to feed your good out boots in believed to is believed to feed your good gut bacteria, helping them a is believed to feed your good gut bacteria, helping them produce blood pressure-lowering compounds called short-chain fatty acids

Trouble is, deli meats are completely devoid of fiber. Better bets are naturally fiber-rich whole foods, like fruits, vegetables, beans, lentils, chickpeas and whole grains. These foods are staples of the DASH diet, an eating plan with a long, proven track record for lowering blood preswith a long, proven track record for lowering blood pressure. But if a turkey sandwich is your only option, order it on whole-wheat bread and pile on the lettuce, tomato, avo-

#### **Roasted Tomato Soup**

Recipe courtesy of "Cookin' Savvy" Servings: 4-6

3 pounds tomatoes

1/2 onion (optional)

1 garlic bulb (optional)

1 tablespoon garlic powder

2 teaspoons onion powder 1 tablespoon sugar

tablespoon mesquite seasoning

avocado oil

- Vegetables. Like fruits, vegetables are loaded with potassium. And they're among the best sources of fiber. Top choices include potatoes, beets, leafy greens, avocados, beans and legumes. Thanks to quick, convenient options like bagged salad and spinach, canned beans and lentils and frozen veggies, getting your fill is easier than you might think.
- Low-Fat Dairy and Dairy Alternatives. Low-fat dairy is another DASH diet staple that's rich in blood pressure-regulating potassium and calcium. "Calcium supports contraction and relaxation of blood vessels," says Hemler. "You don't need to stick to dairy. Yes, milk and yogurt are great, but leafy greens like kale and bok choy, tofu, almonds and calcium-fortified plant milks also count."
- Whole Grains. In addition to dietary fiber, whole grains provide magnesium, which also apports healthy blood pressure. "Magnesium keeps blood vessels relaxed and helps regulate other key minerals like calcium and potassium," says Hemler. To make sure you're getting

the most bang, opt for 100% whole grains when choosing bread, pasta and cereal.

- Fatty Fish. Fatty fish are rich in DHA and EPA, longchain omega-3 fats that have been shown to reduce blood pressure. While all fish are good for you, salmon, mackerel, anchovies, herring and sardines are the best sources of these heart-healthy fats.
- Water. "Consistent fluid intake like water keeps your blood volume stable and helps your kidneys flush out excess sodium," says Hemler. "When you're even mildly dehydrated, your blood vessels can constrict, and your blood pressure may increase." In addition to water, hydrating foods like cucumbers, melons, oranges and lettuce can also help you get the fluids you need, he says.



Deli meats deliver a double-edged sword when it comes to high blood pressure. On one end, they're filled with blood pressure-raising sodium and nitrates. On the other, they're low in fiber, which helps protect against hypertension. That's why deli meats are the No. 1 food to limit to reduce your risk of high blood pressure. We're not saying you can never eat a ham or turkey sandwich again, but the fewer deli meats on your plate, the better. So, next time you need a quick lunch from the deli, order a tuna sandwich

# LAST CALL: These Chain Stores Are Closing Locations in 2023

*The retail sector can often be fickle, even when the company* is loved and established. Some of the titans in the industry have faced tough times in recent years, with even the seemingly infallible ones shuttering locations for good.

From Aldi to Costco, Walmart, and even designer stores, it looks like no one is safe. Business status can change on a dime, but let's see which household names are closing the doors for good in 2023. Will your local store be next – or has it managed to escape the retail apocalypse?

Pet Valu

Year Established: 1975

**Store Closures: 358 Branches\*** 

For decades, Pet Valu was a discount way to get supplies and services for your pets. Fans of the chain were disappointed to learn that Pet Valu was going to close down all 358 of its stores. The announcement was made in November of 2020, and the closures are still ongoing.

Pet Valu said it was winding down all of its operations, including corporate offices and warehouses. The beneficiary of this closure ended up being Pet Valu's former rival, Pet Supplies Plus. Pet Supplies Plus acquired forty of Pet Value's stores, and it announced in December of 2020 that it would rebrand Pet Valu in P.S.P.'s image.

The Gap

Year Established: 1969

Store Closures: 350 branches – all UK and Ireland Locations\*

In addition to as many as 350 store closures worldwide leading up to 2024, The Gap has had a massive restructuring and rebranding happening in an effort to stay ahead of the competition and reduce overhead.

With more than 2,300 domestic locations, former CEO Art Peck predicts that more than 50% of all The Gap's locations could be closing in the coming years as part of this shift. Overseas customers have already seen many Gap stores shuttering in recent years, with especially large cutbacks in Israel and Australia.

Victoria's Secret Year Established: 1977

Store Closures: 30-50 Branches\*

Victoria's Secret was founded by Roy and Gaye Raymond in 1977. The lingerie store is credited with bringing hip, fashionable lingerie into the mainstream. The company later opened its subsidiary Victoria's Secret Pink, which includes apparel and sleepwear. It was Pink that ended up closing first, as Victoria's Secret decided to focus solely on lingerie.

In 2019, Victoria's Secret became the largest retailer of lingerie in the US but has seen sales gradually decrease. To keep revenues up, the company closed more than fifty locations in 2019 and 250 in 2020 in order to compete with the demands of e-commerce.CEP Stuart Burgdoerfer told ABC News, "We would expect to have a meaningful number of additional store closures beyond the 250 that we're pursuing this year, meaning there will be more in 2021 and probably a bit more in 2022."

**Urban Outfitters** 

Year Established: 1970 **Store Closures: TBD\*** 

In the first quarter of 2020, Urban Outfitters' stock dropped a whopping 32%. The store's fate has only worsened in the months since, and one Barrons.com stock analyst said to sell the stock in July of 2020. In-store sales have dropped significantly.

Urban Outfitters has done better on digital sales however, seeing a 76% rise in new digital customers in the second quarter of 2020. However, though digital sales are still sales, retail locations continued to under-perform well into 2021. Urban Outfitters has been around since 1970 infiltrating "trendy" niche in the retail sector. However, it takes more than just a niche to keep a business surviving and thriving. There could be tougher times ahead.

# DIABETES AND WEIGHT-LOSS DRUG 'CHANGED MY LIFE,' SAYS SENATOR: 'I FEEL A DECADE YOUNGER'

views of prioritizing nutrition and healthy living, he said he believes the medications are necessary for some.

"I fully agree that diet and lifestyle matter — a lot. But diet alone isn't enough," he wrote. "For the millions of Americans struggling with serious health issues, medication can be a crucial first step to regaining enough control of their health to begin making meaningful lifestyle changes."

Dr. Marc Siegel, clinical professor of medicine at NYU Langone Health and Fox News' senior medical analyst, noted that semaglutides, including Ozempic and Wegovy, are "very important drugs" for type 2 diabetes, with increasing use for obesity.

"Though these drugs appear to have beneficial uses for the heart and lipid profile — and also the brain and decreasing dementia risk — studies are ongoing and more data is still needed," he told Fox News Digital.

The first approach to obesity is lifestyle changes, including exercise, improved diet and optimal sleep, Siegel said.

"Having said that, these weight-loss drugs (including Zepbound) are also good tools when lifestyle is not enough," he noted.

"They help prevent down-the-line diseases such as heart disease, stroke, high blood pressure and sleep apnea, which tend to come from obesity."

He added, "Overall, we are saving the healthcare system money, so I would like to see Medicare and Medicaid approve them for diabetes and weight loss."

Dr. Brett Osborn, a Florida neurologist and longevity expert, said he's been prescribing GLP-1s to his patients since 2019.

"Mounjaro and its cousins aren't just weight-loss tools — they're metabolic reset buttons," he told Fox News Digital.

"People with metabolic syndrome don't need lectures on kale and the importance of exercise. They need help."

Osborn agreed that lifestyle is essential, but is "rarely sufficient."

"GLP-1s give patients momentum by getting the ball rolling," he said. "And when that happens, health habits are formed. Diet improves. Movement improves. People start to feel the benefits of healthy living."

Osborn noted that these medications aren't cosmetic, but therapeutic.

"I've seen what they can do firsthand: reductions in body fat, inflammation, glucose, triglycerides and insulin resistance — and with those, significant reductions in the incidence of stroke and heart attack."

President Donald Trump's administration recently announced that Medicare and Medicaid would not cover the medications, as the Centers for Medicare and Medicaid Services said late Friday.

Osborn said the move to block coverage likely doesn't have to do with efficacy.

"Trump knows these medications work," Osborn said. "I believe this is a signal aimed squarely at Big Pharma: 'Lower the price, or Medicare, the biggest buyer on the block, is out.'"

"This isn't a dismissal — it's leverage," Osborn said, stating his opinion on the matter. "President Trump will likely negotiate until the 'price is right,' disempowering Big Pharma while concomitantly bettering the health of Americans.

Later in the first Trump administration, Patel served on the White House National Security Council.

The move to place Auten on leave comes after the Trump administration has for months targeted FBI officials who worked on prosecutions of Trump or those who rioted at the U.S. Capitol on Jan. 6, 2021.

In January, the Trump administration forced out six of the agency's senior executives and several heads of FBI field offices across the country.

The Rosita is a modern classic cocktail most often described as a tequila Negroni, though this simplistic explanation vastly undersells the drink. Both involve a combination of spirit, Campari, and vermouth, though the Rosita splits the latter ingredient into equal parts sweet and dry vermouth, making it more akin to a Perfect Negroni. Further, it incorporates a dash of Angostura bitters, to bring added depth to the bittersweet combination.

The Rosita's history is murky, like that of so many classic and modernclassic drinks before it. Iterations of the cocktail date to at least the 1970s, before an early recipe was eventually

featured in the Mr. Boston Official Bartender's Guide. There, it sat buried in the book's pages for years until eventually being unearth and riffed upon by bar legend Gary "Gaz" Regan.

#### **Ingredients**

- 1 1/2 ounces tequila
- 1/2 ounce sweet vermouth
- 1/2 ounce dry vermouth
- 1/2 ounce Campari
- 1 dash Angostura bitters Garnish: lemon twist

#### Steps


Add all ingredients to a mixing glass filled with ice.

Stir smoothly for 15–20 seconds, until well-chilled.

Strain into a rocks glass filled with fresh ice, or single large ice cube.

Garnish with a lemon twist.

Cleopatra VII Philopator (69 BC – August 12, 30 BC) was an Egyptian Queen and the last pharaoh of Ancient Egypt. Cleopatra was a member of the Greek-speaking, Ptolemaic dynasty, who ruled Egypt from 300BC to 30 BC. Deposed from power by her brother, Cleopatra aligned herself with Julius Caesar to regain the throne. After Caesar's murder, she became the lover to Mark Anthony. But, after Mark Anthony had been defeated by the forces of Octavian in




the Roman Civil War, Anthony and Cleopatra committed suicide, rather than fall into the hands of Octavius. Her death marked the end of the Ptolemaic Kingdom of Egypt – and Egypt became absorbed into the Roman Empire.

#### Wild In The City: Some Animals Thrive In Urban Environments

**Dear Earth Talk:** Why do some wild animals live in cities more than in rural areas?

– L.K. via email

When people think of wildlife, they often picture animals wandering in nature. However, in the past

15 years, scientists have found more animals moving into and thriving in cities—sometimes even more successfully than in their natural habitats.

Before learning about why animals are moving to cities, it's important to understand what urban and rural mean. Urban areas are densely populated regions dominated by human activity. Rural areas are sparsely populated with more natural ecosystems. Wildlife that successfully adapt to city

life ae often called urban wildlife. Unlike rural areas, where animals rely on seasonal food cycles, the urban environment provides them with more predictable food sources like waste bins, pet foods and restaurant waste, ensuring a steady food supply.

Thus, animals endure harsher habits in rural areas, leading to greater migration into the city.

"Anecdotally, we see high densities of coyotes in nature preserves and urban parks," said Emily Zepeda, of the School of Environment and Natural Resources from Ohio State University. "Also, in low-income areas, coyotes are 1 1/2 times more likely to survive to age two than in high-income

low-income areas, coyotes are 1 1/2 times more likely to survive to age two than in high-income

areas," due to the amount of human food waste. The presence of humans discourages natural predators, unlike rural areas where predation is a major threat to wildlife. Thus, animals prefer cities, as they can thrive with less competition. Moreover, urban settings provide animals with shelter, like parks and suburban green spaces. Also, warmer microclimates in cities make survival easier for animals that struggle in colder rural areas.

Urban wildlife is adapting to cities in many ways. Lauren Stanton, a PhD candidate at the University of Wyoming, says that raccoons in Toronto "are making rapid associations, and they can alter their behavior." To find more food sources, animals have learned to synchronize their behavior with human activity; for example, raccoons have learned to get inside rubbish bins with securely locked lids. And pigeons typically nest on cliffs, and a multi-story building is indeed a type of cliff, albeit manmade. Therefore, adapting to cities isn't hard for the pigeons due to preadaptation.

Living in cities as urban wildlife isn't easy. There is a risk of vehicle collisions, habitat fragmentation and human-wildlife conflict. Thousands of animals die each year on roads. Humans are also at risk. Animals cause serious road hazards. Bears break into homes and garages to search for food. Ultimately, humans need to balance urbanization with wildlife needs, like expanding natural habitats, thoughtful city planning and wildlife corridors to ensure a future where both species can live together safely and peacefully.



I would still like to play baseball myself, but I was terrible at it. I asked one of my coaches what position I should play, and





The declining state of manufacturing in America is a reliably hot-button political issue. #### **Arrow Shirts**

A legendary company that dates back to 1830 and supplied uniforms to Union troops in the Civil War, Woolrich can no longer boast "Made in USA." The company known for its cozy woolen products and the distinctive red-black Buffalo Check pattern produced goods for other companies like L.L. Bean and Eddie Bauer in addition to its own line of goods. Eventually production started moving overseas to China, Vietnam, and other countries. In late 2018, the company announced the closure of its Pennsylvania plant.



Gillette is an iconic U.S. company known for its razors and

shaving cream. Aside from its products, the Gillette name is also displayed on a stadium in Massachusetts where the New England Patriots play. But according to advertising watchdog group TINA.org, the company overhyped its connection to



Beantown when its advertising spotlighted the company's Boston headquarters. The company makes its products in several other countries, such as China, Mexico, and Brazil, the group says, and Gilette shouldn't be implying broad "Made in USA" cred.

n't too common. For that reason, they've shot up in value as the decades have passed. On eBay, Ralston holographic Batman cereal boxes sell for around \$40.



### 10 OF THE MOST VALUABLE PENNIES

ou don't need to be a coin collector to have piggy banks stashed around your house filled with quarters, dimes, nickels or pennies. However, you may not be aware of the potential fortune you have hoarded away that could be worth more than just some extra spending cash.

Some of the pennies lying around your house could far exceed their face value of one cent. Let's take a deeper dive into the world of pretty pennies.

#### **Pennies Worth Money: Quick Take**

Rare pennies are worth real money, especially if they are uncirculated or in good condition. Here are a few key takeaways:

The United States Mint only releases a certain amount of pennies annually. If the mintage is lower in a particular year, this will only help increase the value

Examples of low mintage years include, but are not limited to, 1931, 1933, 1939 and 1955.

If your penny has a mistake this could increase the value exponentially as error coins are worth more to collectors due to their rarity. It can't hurt

#### 3. 1793 Strawberry Leaf Cent — \$862,500

In 2009, the Strawberry Leaf penny broke records for the most money paid for a penny at an auction, going for \$862,000. The Strawberry Leaf cent is extremely rare, bearing a four-leaf strawberry plant on the tail of the coin instead of the normal three-leaf trefoil.

Only four of these coins exist, so if you find one, you'd be very lucky indeed. It would be luckier than finding a four-leaf clover.

#### 4. 1943-S Lincoln Cent Struck on Bronze — \$282,000

The U.S. transitioned away from bronze pennies in 1943. But a few bronze planchets, a blank coin with no design, may have been left behind, resulting in extremely rare and valuable 1943-S bronze pennies. In 2016, one of these pennies sold at auction for \$282,000.

#### 5. 1909 VDB Matte Proof Lincoln Penny – \$258,000

Older coins tend to be worth more the longer they are around. Matte-proof coins tend to be highly

bottom of Lincoln pennies, the designer of the Indian Head — James Longacre –started slipping an L for his last name on the ribbon toward the end of 1964.

These pennies are loved and coveted by collectors, with one going for \$161,000 at auction. If you happen to have one of these rare coins lying around in less-than-mint condition, you can still get around \$40 for it.

#### 9. 1914-D Lincoln Penny — \$159,000

Lincoln Cents minted between 1909 and 1958 are popular amongst collectors. The 1914-D coin is very rare, with just 1.2 million minted. You can find these pennies ranging from hundreds to thousands on eBay, but one of the pricier coins in mint condition sold for \$159,000.

#### 10. 1926-S Lincoln Penny — \$149,500

It might be wise to take a look through your pockets for any Lincoln wheat pennies, as these coins tend to sell for more than face value even if they aren't in mint condition. But if you spot a red Lincoln penny from this era, it might be time to



to examine any pennies in your pocket, as any small mistakes or errors could mean big money.

If you think you may have pennies worth money, make sure you get to a reputable coin dealer or professional coin grading service.

#### 1. 1943-D Lincoln Bronze Wheat Penny — \$2.3 million

Designed by Victor D. Brenner, this is one of the highest-value pennies in circulation today. During World War II, pennies were made of steel to save copper for the war effort. However, a few were mistakenly made of bronze, and these are extremely rare and valuable. Made of 95% copper and 5% tin and zinc alloy, it sold for \$1.7 million in 2010 but is valued at \$2.3 million in mint uncirculated condition.

More recently, it went for \$840,000 at an auction. There is only one copy known to be in existence, as it was mistakenly struck at the Denver Mint on a bronze planchet, but other versions of the coin may sell for \$100,000 and up. If you have any 1943 wheat pennies, it's worth taking them to a coin dealer to see how much you might get for them.

#### 2. 1944-S Steel Wheat Penny — \$1.1 million

This penny somehow missed the 1944 transition from steel-coated zinc to copper, and it's worth a fortune as a result. Just two copies of the San Francisco-minted version remain. Circulating coins are worth \$408,000 to \$409,000 in average condition and upwards of \$1.1 million for uncirculated condition.

coveted amongst collectors, and this 1909 VDB version is the most desired. You can tell it is authentic from the square, sharp-edged rims and the details. This rare coin from 1909 sold at auction for \$258,000. It is unique because it bears the designer's initials — VDB —on the bottom.

#### 6. 1958 Doubled Die Obverse Cent — \$224.831

This Doubled Die Lincoln cent commands some of the highest prices at auction because there were only a few minted. This error coin was struck at the Philadelphia Mint and you'll recognize one by the "doubled" lettering of the words "In God We Trust" and "Liberty."

On the 1958 version, you'll also see that the date is slightly doubled, too. An uncirculated version of this coin is worth \$224,831.

#### 7. 1856 Flying Eagle Cent — \$172,500

The Flying Eagle cent may not be as rare as the 1943 Lincoln cents, but they are still worth more than six figures. More than 600 of these coins were given to politicians and others during the original minting, but additional coins were re-struck from the original dies in 1858 and 1859. These coins can range in price from \$4,500 up to \$172,500.

#### 8. 1864 Indian Head Penny "L" on Ribbon – \$161,000

After Flying Eagle Cent was minted, the federal government transitioned to the Indian Head Penny in 1864. Like VDB, who struck his initials on the

book that luxury vacation you've wanted. A 1926-S Lincoln cent in mint condition with its red surface intact sold for \$149,500 at auction in 2006.

#### How Do You Know if a Penny Is Valuable?

The pennies on this list above are worth hundreds of thousands or even millions of dollars. But keep in mind that a lot of factors determine a penny's value. First of all, coins that are rare and were minted in smaller quantities may be worth more money decades — or centuries — later. If a rare coin is in excellent condition, it could be worth even more.

Collectors and numismatics professionals use something called the Sheldon Scale to grade coins on a scale of 1 to 70, with coins rated at 70 holding the highest value. Color, the coin's wear and its rarity all contribute to its grade and value.


Finally, a penny is only valuable if you can get someone to pay you what it's worth. Make sure to work with a reputable coin dealer and do your research to ensure you are getting top dollar for your coins.

#### Final Take To GO

It's easy to dismiss a penny when you pass by it on the sidewalk or accidentally leave it in your 1 pants pocket when you do a load of laundry. It can't hurt to do a little treasure hunt in your forgotten to coin collection to see if you may be sitting on a fortune.
